This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Description: Carmignac Portfolio Investissement is a sub-fund of the Carmignac Portfolio SICAV regulated by Luxembourg Law. Carmignac Portfolio fulfils the conditions set out in Directive 2009/65/EC and is registered with CSSF under number 2530.

Name of the initiator's Supervisory Authority: Carmignac Gestion Luxembourg is a UCITS management company approved by the CSSF.

WHAT IS THIS PRODUCT?

TYPE

Carmignac Portfolio Investissement is a segregated sub-fund of Carmignac Portfolio SICAV, an investment company with variable capital regulated by Luxembourg law and qualifying as UCITS pursuant to Directive 2009/65/CE.

TERM

The SICAV was launched on 30/06/1999 for unlimited period. The sub-fund was launched on 15/11/2013.

OBJECTIVES

The sub-fund aims to outperform its reference indicator over a period exceeding five years. In addition, it seeks to invest sustainably for long-term growth. The reference indicator is the MSCI AC World NR index.

The sub-fund is invested in international equity markets all over the world. Its main performance drivers are as follows: (i) Equities: at least 60% of the sub-fund's net assets is permanently exposed to international equities (all capitalisations, without restrictions in terms of sector or region, including emerging countries). Up to 10% of the Fund's net assets may be invested in unlisted securities selected by the portfolio manager and (ii) Currencies: the sub-fund may use currencies other than the Fund's valuation currency for exposure or hedging purposes. The manager may use Relative Value strategies as performance drivers, looking to take advantage of the relative value between different instruments. Short positions may also be taken through derivatives. The sub-fund may be invested in transferable debt securities and bonds on an ancillary basis.

The sub-fund uses derivatives for hedging or arbitrage purposes, or to expose the portfolio to the following risks: currencies, bonds, equities (all categories of capitalisation), ETFs, dividends, volatility, variance (the latter two categories for up to 10% of net assets) and indices: on all asset classes mentioned above plus commodities (up to 20% of assets). The derivatives available are options (vanilla, barrier, binary), futures and forwards, swaps (including performance) and CFDs (contracts for difference) on one or more underlyings. The overall modified duration of the fixed income portfolio is between -4 and +5. Modified duration is defined as the change in portfolio capital (as %) for a change in interest rates of 100 basis points. Up to 10 % of the net assets may be invested in contingent convertible bonds ("CoCos"). CoCos are regulated subordinated debt instruments that are complex, but consistent in nature. Please refer to the prospectus for more information. The sub-fund may invest up to 10% of its net assets in units or shares of investment funds.

This sub-fund is an actively managed UCITS. The investment manager has discretion over the

composition of its portfolio, subject to the stated investment objectives and policy. The sub-fund's investment universe is at least partly derived from the Reference indicator. The sub-fund's investment strategy is not dependent on the Reference indicator; therefore, the sub-fund's holdings and the weightings may substantially deviate from the composition of the Reference indicator. There is no limit set on the level of such deviation.

The sub-fund promotes environmental/social characteristics in accordance with Article 8 of the Sustainable Finance Disclosure Regulation ('SFDR') through best-in-universe and best-effort approaches, and an active engagement policy. Extra-financial analysis leads to a reduction of at least 20% of the sub-fund's investment universe via a negative filter excluding companies whose extra financial ratings reflect high risks. In addition, the sub-fund invests at least 50% of its net assets in sustainable investments within the meaning of SFDR, and targets carbon emissions (tCO₂/ mUSD revenue converted to Euros; aggregated at portfolio level ; Scope 1 and 2 of GHG Protocol) 30% lower than those of its benchmark. The sustainable investment definition used by the sub-fund uses the United Nations Sustainable Development Goals ('SDGs') framework. This framework is one of several that can be used to illustrate positive results; others may yield different results. The sustainability risk of the sub-fund may differ from that of its reference indicator.

INTENDED RETAIL INVESTOR

This sub-fund is intended for private and institutional investors wishing to diversify their investments while benefiting from market opportunities through reactive asset management over a recommended investment period of more than 5 years, due to the sub-fund's exposure to the equity market.

The appropriate amount to invest in this fund depends on the personal situation of the investor, their knowledge of investment products and experience, their personal wealth, their cash requirements now and in the future, and their degree of risk aversion.

OTHER INFORMATION

This is an accumulation share.

Investments may be redeemed each business day on request. Subscription, redemption or conversion requests are centralised on each NAV calculation and publication day before 15:00 CET and are executed on the next business day using the previous day's NAV.

The Depositary of the sub-fund is BNP Paribas, Luxembourg branch.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator : the summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

Risks not sufficiently considered by the indicator include:

- Counterparty risk: the sub-fund may suffer losses if a counterparty defaults and is unable to meet its contractual obligations, especially in the case of derivatives traded OTC.
- Liquidity risk: the markets in which the sub-fund participates may be subject to temporary illiquidity. These market distortions could have an impact on the pricing conditions under which the sub-fund may be caused to liquidate, initiate or modify its positions.
- Risks associated with China: investing in this sub-fund entails risks associated with China, especially risks associated the use of Stock Connect (a system facilitating equity investment in the A shares market via a Hong Kong-based entity acting as the sub-fund's nominee). Investors are advised to familiarise themselves with the specific risks of this system, as well as with other risks linked to investments in China (CIBM, RQFII status...) as outlined in the prospectus.

The length of the recommended holding period is 5 years.

WHAT HAPPENS IF CARMIGNAC GESTION LUXEMBOURG IS UNABLE TO PAY OUT?

For your protection, the assets of the fund are held with a separate entity, the custodian, so that the fund's ability to pay would not be affected by the insolvency of the management company. In the event of failure of the latter, the assets of the product held by the depositary will not be affected. In the event of default by the depositary, the risk of financial loss of the product is mitigated due to the legal segregation of the assets of the depositary from those of the product.

WHAT ARE THE COSTS?

* The Reduction in Yield (RIY) illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 14.29 % before costs and 10.59 % after costs. The total costs take into account one-off, ongoing and incidental costs.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Due to the sub-fund's exposure to the equity market, the recommended investment period is over 5 years. However, you can redeem your investment without incurring any penalties at any point during this period, or stay invested for longer. Redemptions are possible each business day. A redemption gate mechanism can be activated when net redemptions exceed 10% of the fund's net assets, resulting in the partial execution of redemption requests and the carryover of the balance to one or more subsequent net asset values. Furthermore, a swing pricing mechanism is in place. This allows for adjustments to the net asset value when net subscriptions and redemptions reach certain thresholds, in order to cover the cost of portfolio restructuring following significant changes in liabilities, with the aim of protecting the interests of unit holders.
