Grâce à une indication de performance cible⁽¹⁾, une date de maturité préétablie et une sélection rigoureuse et diversifiée des émetteurs, le Fonds offre aux investisseurs de la visibilité sur leur placement. Carmignac Credit 2027 cherche à offrir une appréciation du capital investi en ligne avec sa stratégie de portage sur un horizon de 5 ans, tout en permettant aux investisseurs de profiter d'une échéance anticipée si le taux de rendement interne du Fonds atteint l'un des seuils définis dans le prospectus avant le terme⁽¹⁾. *L'objectif du Fonds ne constitue en aucun cas une promesse de rendement ou de performance du Fonds, la performance n'est pas garantie.*

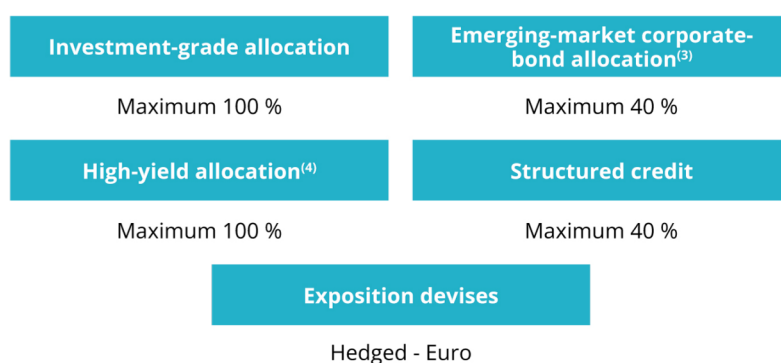
An early maturity option during the third and fourth year if pre-set conditions are met, to allow investors to recover their investment prior to maturity.

A conviction-driven investment process that seeks to identify attractive premiums on various segments in the credit universe, in order to build a diversified but selective portfolio.

Risks that recede over time and that are managed rigorously, thanks to the target date and systematic hedging of currency risk.

RIGOROUS SELECTION OF ISSUERS FROM ACROSS THE ENTIRE INVESTMENT SPECTRUM

In constructing the portfolio, the Fund managers draw on both their convictions and in-depth analysis of each opportunity examined. This investment process is what enables them to capture complexity premia available in the credit markets, based on a conservative estimate of the fundamental cost of risk⁽²⁾. This analysis is also used to determine the terms and conditions for exercising the early maturity option, and particularly to calculate the minimum internal rate of return that the Fund must have achieved.



MAIN RISKS OF THE FUND

CREDIT: Credit risk is the risk that the issuer may default. **INTEREST RATE:** Interest rate risk results in a decline in the net asset value in the event of changes in interest rates. **LIQUIDITY:** Temporary market distortions may have an impact on the pricing conditions under which the Fund might be caused to liquidate, initiate or modify its positions. **DISCRETIONARY MANAGEMENT:** Anticipations of financial market changes made by the Management Company have a direct effect on the Fund's performance, which depends on the stocks selected.

INVESTMENT OBJECTIVE

Launch date: 02/05/2022

Objective: The investment objective is to offer performance, net of management fees, from a portfolio made up of securities from public or private sector issuers (including securitisation instruments representing up to 40% of net assets), with no restrictions in terms of average rating, duration, maturity or public/private split. The fund will therefore be exposed to the credit markets as well as the fixed income markets. With no restrictions on average rating, the fund aims for potentially high exposure to high yield debt securities which offer higher potential yields than investment grade debt securities (rated at least BBB or equivalent, or of credit quality deemed equivalent by the portfolio manager), but expose the fund to a higher level of risk (in particular that of issuer default). The portfolio is intended to be held until a liquidation period beginning six months before the fund matures on 30 June 2027 (buy-and-hold strategy), or until any early maturity date:

- No later than 3 April 2026, if the fund has achieved or exceeded a performance deemed appropriate and corresponding to the IRR observed between 30 June 2022 and 27 February 2026 (the "Target IRR") of 2.08% for the A EUR Acc and Ydis units, 1.77% for the E EUR Acc and Ydis units, 2.49% for the F EUR Acc and Ydis units, i.e. a net asset value of EUR 107.83 observed on 27 February 2026 for the A EUR Acc unit, EUR 106.65 for the E EUR Acc unit, EUR 109.42 for the F EUR Acc unit, or an equivalent performance over the period, dividends reinvested, for the A EUR Ydis, E EUR Ydis and F EUR Ydis share classes, respectively.
- No later than 4 August 2026, if the fund has achieved or exceeded a performance deemed appropriate and corresponding to the IRR observed between 30 June 2022 and 30 June 2026 (the "Target IRR") of 1.94% for the A EUR Acc and Ydis units, 1.64% for the E EUR Acc and Ydis units, 2.35% for the F EUR Acc and Ydis units, i.e. a net asset value of EUR 108 observed on 30 June 2026 for the A EUR Acc unit, EUR 106.71 for the E EUR Acc unit, EUR 109.74 for the F EUR Acc unit, or an equivalent performance over the period, dividends reinvested, for the A EUR Ydis, E EUR Ydis and F EUR Ydis share classes, respectively.
