Carmignac Portfolio China New Economy is an equity fund looking to seize investment opportunities arising mainly, but not exclusively, from China's New Economy. The latter offers numerous sustainable growth themes in areas such as healthcare, education, clean energy, technological innovation and new consumption, including e-commerce and new consumer goods which benefit from the increasing purchasing power and improving living standards of Chinese households. The Fund follows a socially responsible investment (SRI) approach and its objective is to outperform its reference indicator over at least 5 years. It also looks to minimize its environmental impact by reducing its carbon footprint by 5% annually and is classified as Article 8 according to the SFDR⁽¹⁾.
