

INVESTMENT OBJECTIVE

Investments are then made in the names with appealing asymmetric risk/return profiles. The fund aims to outperform its reference indicator over 5 years and to generate capital growth, while implementing a socially responsible investment approach formalised by a sustainable investment objective.






NET CURRENCY EXPOSURE OF THE FUND
