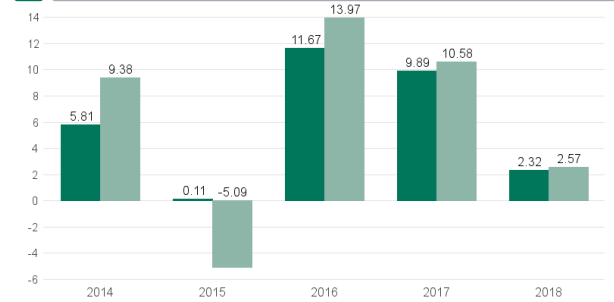

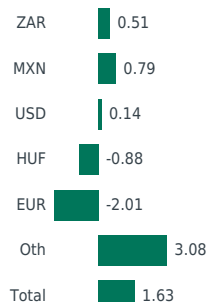

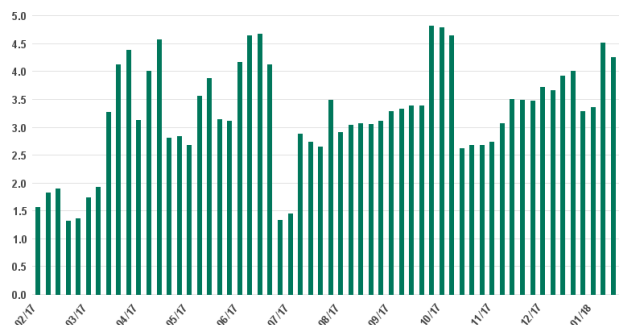

Currency Breakdown - Modified Duration



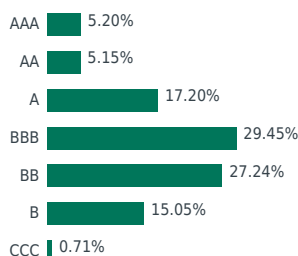
Modified Duration - 1 Year Period



Management Comments

The Fund turned in a positive performance but trailed its reference indicator slightly. Most emerging markets ended the month higher. Our fixed income investments boosted performance, mainly benefitting from our positioning on Brazilian and Mexican local sovereign debt. Our Greek government bonds also did well, but our positioning on corporate bonds from the energy sector weighed on performance.

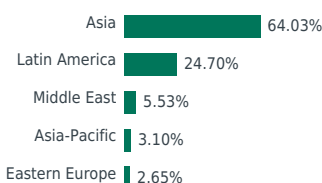

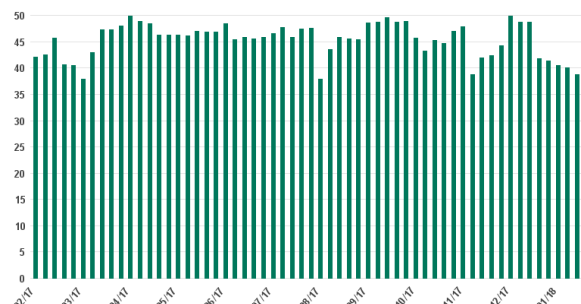

Country Breakdown - Equity Component



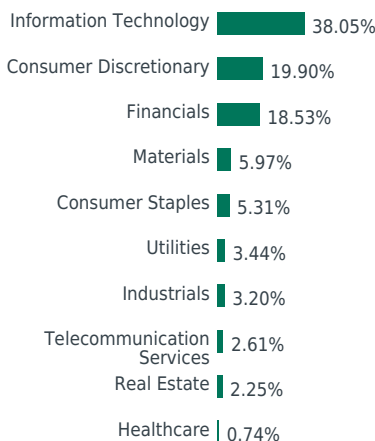
Equity Exposure - 1 Year Period (%AUM)



Management Comments

Our equity investments weighed on the Fund's relative performance despite making positive contributions. We particularly suffered from our underexposure to Chinese markets, especially Chinese banks, which performed well. However, we benefitted from our exposure to Argentina and Mexico, with e-commerce company MercadoLibre (Argentina) and banks Grupo Supervielle (Argentina) and Grupo Banorte (Mexico) among the main sources of performance. We are keeping equity exposure high.
